**Welcome and Introductions:** Nate Low brought greetings and introductions

<u>Simplot Company:</u> Rick Phillips and Mandy Harrison from JR Simplot Company discussed the Career Pipeline Initiative. How can FFA and Simplot work together to create an internship connection? They look for students who have good leadership skills, a good resume, present themselves well, and have good work ethic. Must be willing to accept entry level positions. From 7 states Simplot had 45 interns but this varies from year to year. Must have completed freshman year in college. Discussion centered around how to let kids know about careers available. (Online resources, Simplot people from around your area doing presentations to individual classes.) Possibility of workshops as Ag Teachers we need to come up with a list of needs.

**Review of Minutes:** JR Morrow moved to approve the minutes as presented. No discussion. The motion passed unanimously.

<u>Food Producers of Idaho Report:</u> Fred Faulks discussed the history and influence of Food Producers in our state and how it affects our Ag Programs. Fred explained what the Food Producers do and the processes they go through. They support The Ag research facilities in our state, they tour many of these and they support the Leadership Idaho Agriculture program. They meet weekly starting in February. Shaun Dygert moved to continue to have Fred represent us on the Food Producers and to pay for his ticket to their banquet. Motion passed unanimously.

<u>Alumni report:</u> Chuck Radloff, Alumni Chair reported. All local Alumni or support groups should be part of the state alumni. They will be a group to help with fundraising efforts and support the Idaho FFA Foundation. National lifetime dues are \$150.00 plus \$100.00 for state. Annual dues are \$10.00. Alumni has a national and a state website that provides materials and information to get started. Commendation was given to Chuck for working very hard at getting the Alumni started. Please let Ben know about people interested in being in Alumni in your area so that Chuck can contact them.

<u>Foundation Report:</u> Kevin Barker reported the following regarding the foundation: \$148,344.00 Total amount, \$108,988 in the endowment, \$63,000 still in old investment that is being moved to DL Evans as fast as possible without penalty. And that the tractor raffle will have 14, \$1000.00 scholarships available and that the goal for next year is to double that amount.

**IVATA Membership Report:** Discussion about explaining why to become a member at summer conference before handing out membership sheets

A motion was made that the IVATA President to send a letter to National FFA Foundation, Ernie Gill, and the national advisor that we do not support their solicitation practices. Please stop!

**<u>Legislative report.</u>** Shawn Dygert talked about the value added tag line for e-mail addresses.

How do we respond to the issues? i.e.: Mandatory online aspect of requirements. Should we try to eliminate mandatory. We can use the IEN network to our advantage? Online classes have not been approved for PTE funding if you turn your class over to take it online from another teacher. We need to define what will and will not work so that we can be proactive and provide our own solution.

Shawn Made presentations to Food Producers they would have taken us as one of their concerns if our funding would have been in jeopardy. So it is worth maintaining our membership.

Child labor laws changes were discussed and how our legislators reacted.

Carl Perkins is to be redone starting this year. Sen Risch will need to be brought up to date and rep Simpson is on the committee that will address it. We can show that it is money well spent and there is a product.

Motion was made by Kevin Barker to pay for a plane ticket to the National Policy seminar for Shawn Dygert and it passed. NAAE will pay registration and Kuna HS will pay hotel cost.

<u>CTEI Report:</u> Amy Nichols reported that there is a 500.00 dollar grant available we just need to decide what we should spend it for. It is a possibility of paying for some sort of teacher in-service at Smoky Mountain Mine.

**NAAE Report:** Pat Dixon reported that at NAAE the main focus was the child labor laws. Nate talked about NAAE removing the amount for dues from by-laws so they can change it without a big vote.

You can increase your liability coverage to 1 million for 35.00/year. You get 100,000.00 with your dues. Alan will add this option to the dues form.

There was a lot of focus on teachers and students to start using the Ag Career Network. This will give National FFA a lot of data they can use.

Region 1 Conference is in Bellingham, WA April 17-20 all members are encouraged to attend. Look into getting a passport as part of the tours may be in Canada.


