 - b. Membership includes: \$100,000 insurance policy, CTEI membership
 - c. ACTE is an additional membership option they advocate for us at a national level
 - d. Checks can be made out to IATA or IVATA; payment also acceptable by credit card

 - a. What makes teaching ag in Idaho great? What do we need to do to make it better?

 - a. We are in the third application cycle of IQPS
 - b. 27 people at state leadership conference met with Amy to give feedback in the focus group. These are the recommendations from the focus group:
 - i. No cooling-off period
 - ii. Lower the distribution amount to \$6,000 instead of \$10,000

- iii. Startup grant be expanded to make new programs eligible for 3 years (they can still only receive the grant once); this grant is available to new programs or programs that have been restarted after being dormant for at least 2 years
- iv. Changes made through this process will not take effect until the 4th IQPS cycle

- 2. CTE Dwight Johnson, Idaho Division of CTE
 - a. Dwight is serving on the governor's task force for career and technical education.
 - i. There is great support from business and industry
 - ii. The committee is exploring the possibility of extending CTE into 7th and 8th grade
 - iii. The task force and CTE office recognize and are trying to address the CTE teacher shortage
- 3. IQPS Report Amy Lorenzo, Idaho Division of CTE
 - a. Idaho Division of CTE has gathered input from focus groups in April and at this summer inservice regarding IQPS:
 - i. Annual eligibility
 - 1. There will be no cooling-off period
 - 2. If there are more eligible teachers than there are funds, the teachers who met the requirements but did not receive funding will have priority the following year if they continue to meet eligibility requirements
 - We will need to communicate to administrators that this change in process is not punitive; it is a way to increase the opportunities for participation
 - ii. Distribution of funds
 - 1. Funding amount will not change. It will continue to be \$10,000
 - iii. Increasing Applicant Pool
 - 1. Prioritization process and maintaining the integrity of the \$10,000 process will probably increase participation in the grant process
 - iv. Startup Grant
 - 1. Eligibility

- A school can apply for the grant within the first 3 years of approval
- 2. Distribution of startup funds
 - a. There was no consensus on addressing this issue, so distribution will continue to be one \$25,000 grant as it has been
 - b. CTE has requested additional funding to fund an additional startup grant
- 4. CDE Committee Report Joe Blackstock
 - a. CDE Revisions Process
 - i. Revision process is every 5 years
 - ii. In Idaho, our revision year is the year after the national revisions so we can consider the national rules while deciding what is appropriate for Idaho
 - iii. The committee sent out a survey to get comments and feedback for CDE revisions from members
 - iv. This year the CDE committee was closed because the feedback had already been gathered, decisions had been made, and the committee was finishing up the process of finalizing the revisions
