 - i. We are absorbing and working with the Washington D.C. vaccine mandate as of yesterday (1/5)

b. Affiliation

 - 1. Attempting to do this 100% revenue neutral which is 5.5 million dollars

 - ii. New Teacher Documents/ Resources
 - 1. It is being condensed to help aide new teachers with all of the information
 - 2. Mentors please contact Lucas with any helpful resources
 - 3. The division does not know of any new hires until October when ISEE codes are completed
 - 4. CONNECT (formerly REACH) is 3 separate conferences throughout the state. Tours are scheduled in each location LCSC (September 21-24) conference will have a tour at U of I for Precision Ag, CEI (August 3-6) (Eastern Idaho) BYU-I

- tour at greenhouses, as well as Fish and Game (Yellowstone?) tours. CSI (July 13-16) new animal science and food processing.
- 5. Dual Credit and Academic Credit— SDE 9921 endorsement allows for science credit, economics credit requires an endorsement, and a speech endorsement for speech credit. You will also need to crosswalk the standards and get approval for SDE.

7. UI Ag Ed/ Extension Ed Department Report- Dr. Jim Connors, and Dr. Kattlyn Wolf, UI Ag Ed/ Extension Ed

- a. Proposal to university to expand CDE's
 - i. 1050 students at CDE's
 - ii. Deans/faculty were thrilled with CDE's
- b. Vandal Ideas Grant
 - i. To hire 2 interns
 - 1. They would be responsible for registration and scoring the invitational
- c. Expand CDE's
 - i. Regular summer CDE's to advance on to Nationals
 - ii. Invitational for 4H, Washington or Oregon FFA, or alternates
 - 1. Some events would be limited to the number of teams
 - a. Ag Mech and Meats
 - 2. To include more tours and activities with the students for more recruitment to the University
 - 3. Ag Ed would be doing the score cards
- d. New ICCU Arena
 - i. Moving to that facility for the orientation for Tuesday night
 - ii. Livestock will stay on Tuesday before the opening session
 - iii. Ag Teacher dinner, awards ceremony
- e. State CDE's

- i. \$35 registration fee per student
 - 1. Also registration fees for advisors, but not bus drivers or chaperones
- ii. Due by May 31st
