- CDE Committee

  - Employment Skills doesn't reference Gregg's Manual in the rules any longer.
     Instead it provides a sample resume.
  - Joe Blackstock moved that we reference the National Resume samples for the LDE - Kelsey Williams seconded - Motion passed.

#### SAE Committee

- Why must a skill area be entered for every single entry in AET
- State Degree tests will be available to take on the 18th
- Pass rate on the AET tests would be an 80% rather than a 60%
- Could tests be taken at any point during a students high school career and carry over to be used for the state degree tests
- SAE Committee will need to be voted on to change from a special committee to a standing committee

### AFNR/ State FFA Advisor Update-- Lucas Barnett

- American Degrees
  - Should be turned in to Lucas by February 15th if you want time to edit
- Idaho FFA Website
  - Has been updated with a calendar in the Advisor's Corner
- IQPS and Other Grants
  - IQPS is being converted to a OneDrive format. Several chapters have tried out the new format and can help if needed
  - PQI has a new start up grant but AFNR programs would not be eligible because of the IQPS start up grant
  - Start up grants may transition to allow cluster programs to receive it if they are transitioning into a pathway program. This will be discussed further at a later date, possibly June.
  - IQPS, 38 total applied with 8 rolling over for next year.

- Miller Training Session
  - Lucas was asked by Jack Blattner to mention that Jack is looking for potential dates in June for a Miller Training session.

### Idaho FFA Foundation-- Marcia Jedry

- Grants and Scholarships
  - o Gift of blue. 68 jackets were given out.
  - WLC is cancelled for 2021
  - Peterson Dodge and Peterson Chevy is offering scholarships to chapters in the treasure valley
  - Emerge grants are available for programs
  - Tractor Raffle has raised over \$30,000 already this year. Please keep selling tickets and make sure to send in money and ticket stubs to the foundation
- State Convention
  - Leadership workshops being coordinated by the foundation. There will also be a scavenger hunt with \$1000 to \$500 for the winners and a fourth prize going to a random chapter
  - Registration fee will still be \$35 per student for state convention
    - There will be a "convention in a box" sent to chapters that register that includes some interactive pieces.
    - Flat rate available for chapters???

### IDCTE Program Quality Update-- Justin Touchstone

- PQI Incentive Grant
  - Ag Teachers are not eligible
- TSA's
- Added cost funding process
  - Fully automated system with ICEE
  - Some teachers were bumped below 0.8 FTE if they taught a middle school class or an advisory period. There is a 6 digit course code for a CTE advisory class
  - Local annual application. Districts must verify the information and Justin will be putting that information in
  - No additional funds until maybe 2023
  - Should added cost funds be based on the number of pathways taught or the number of teachers at the school
- Build Idaho Grant Money
  - State legislature gave CTE 1 million dollars to secondary programs for the modernization of programs and equipment.
    - Applications due end of January
