#### 2022-25 STRATEGIC PLAN

# BOARD APPROVES DELEGATE RECOMMENDATION REGARDING FFA CEREMONIES

During its May 2023 meeting, the National FFA Board of Directors approved the National FFA Delegates' recommendation to provide optional terminology for official FFA ceremonies. The board approved upholding the tradition of using mister or madam in official ceremonies while adding the option of using officer position and last name based on an individual's preference. The delegate-led Membership Experience Improvement Committee at the 95th National FFA Convention & Expo recommended this change. Read more about this decision on FFA.org.

#### **REMOVING BARRIERS TO FFA THROUGH 100% MEMBERSHIP**

The National FFA Board of Directors continues to advance plans to enact 100% membership by the 2027-28 school year. Nineteen states currently follow the 100% membership model. State staff have reviewed three unique fee proposals and many states are engaging in conversations about how to enact the program in each state. In late October, state staff at their annual NASAE meetings will review a new fourth model that is a hybrid of earlier models and the current National FFA Affiliation fee table. Visit with your state staff if you have questions or ideas for the program. No specific fee model has been selected.

#### **AFNR STANDARDS REVISION**

The National Council for Agricultural Education (The Council) is continuing the process of revising the Agricultural, Food, and Natural Resources (AFNR) content standards. This process includes revising the eight existing pathways and developing a new pathway focused on agricultural education, communication, and leadership. In addition to revising the content standards, Career Ready Practices, AFNR Cluster Skills, and crosswalks will be updated. The revision process is expected to be complete in the spring of 2024.

#### NATIONAL QUALITY PROGRAM STANDARDS REVISION

The Council will begin the revision process for the National Quality Program Standards (NQPS) in January 2024 and is seeking volunteers to serve on the project working groups. All meetings will be held virtually and the project will require a 10–15-hour total time commitment from January to June. #### SAE FOR ALL TRAIN THE TRAINER

The Council, in conjunction with NASAE, is excited to announce the re-rollout of SAE for All Train-the-Trainer events. The Council will host two upcoming events — Jan. 25-26, 2024, and Feb. 8-9, 2024. The January dates will be at the immediate conclusion of the Ag Ed Inservice and the February event will be at the National FFA Center. In addition, a virtual training will be available. The goal is to train at least three individuals from each state, including a teacher educator, state staff and a classroom teacher.

#### **VETERINARY SCIENCE CAREER DEVELOPMENT EVENT**

The 2024 Veterinary Science Career Development Event (CDE) will focus on two case-based scenarios that blend general knowledge, math, identification, clinical and handling/restraint practicums, and team activity. The two scenarios for 2024 will focus on vesicular lesion Investigations In swine, bovine, and equine and small animal wellness visits. Additional resources on these topics can be found here.

#### **AWARDS AND RECOGNITION TIMELINE OF CHANGES**

Over the next two years, the timeline for the release of CDE/LDE updates and handbooks will be adjusted. The new <u>timeline</u> will be posted on the CDE/LDE webpage. This adjustment results in an earlier announcement of the Planning Guide and the release of final handbooks for the convention year.

<u>Lesson plans and student activity sheets</u> reinforcing the FFA Value Statements are now available. The value statements create a foundation for FFA to ensure opportunities and platforms are developed that open doors and remove barriers for every individual in agricultural education to experience premier leadership, personal growth and career success.

#### **NEXT GEN CONFERENCES**

The Next Gen Conference allows students to explore a specific pathway through informational sessions, panels and tours. Participants will experience new and emerging ideas, trends and products; cutting-edge technology; sustainability; and more. They will delve into literacy and advocacy as well as diversity, equity and inclusion all while exploring various careers in the pathway. The competitive application process is open to high school sophomores, juniors and seniors.

#### **GIVE THE GIFT OF BLUE**

The purpose of this program is to gift jackets to members who would not otherwise be able to afford one. Based on the increase in applicants and to ensure each chapter has an equitable opportunity to have an application reviewed and a jacket awarded, there is currently a limit to the number of jackets each chapter is eligible to receive.

Applications are being reviewed and processed as funding becomes available. Typical turnaround time for jacket delivery is three to four weeks. There is still an urgent need for program support. Anyone can support Give the Gift of Blue at FFA.org/giveblue/.



#### **SCHOLARSHIPS**

The <u>National FFA Scholarship application</u> closes January 11, 2024. Check the <u>resources</u> button for a new How to Guide and FAQs.

Changes for the 2023-24 scholarship year include:

- New management system
- Advisor statement no longer needed
- Advisor receives email when student begins application

As a reminder, the following changes went into effect in the 2022-23 scholarship year:

- Open to FFA members only
- Essays and test scores no longer required
- Ford dealer endorsement no longer required
- One application for all scholarships with no opt-ins
- Scholarships available specifically for skilled-trade training
- Scholarships available specifically for physically disabled members
- Streamlined scholarship award collection process utilizing ACH transactions to institutions
- Members may apply up to four times provided they are of eligible FFA membership age and an undergraduate student
- Provide a personal email address (rather than one tied to a school) to ensure notifications are received
- Acceptance by the student recipient must be completed by May 31 to avoid forfeiting the scholarship funds

#### **LOCAL SUPPORT**

#### **ZOETIS INDUSTRY SUPPORT PROGRAM**

Zoetis distributors, dealers, and veterinarians are eligible to enroll in the Zoetis Industry Support Program that designates 1% of eligible purchases to the local FFA chapter of their choice. Chapters are encouraged to reach out to express interest in the program and follow up after checks are distributed each fall to express gratitude and make an industry connection with animal health professionals. #### **GRANTS FOR GROWING**

Grants for Growing are funded by FFA paper emblem sales at Tractor Supply stores during National FFA Week. The grant is designed to support middle and high school FFA chapters in developing and improving project-based or experiential learning opportunities for students. #### LIVING TO SERVE GRANTS

Spring semester-long grant applications are due Feb. 1, 2024. Chapters can be awarded up to \$1200 to implement a service-learning project in their community for the semester. Apply here!

Mini-Grants provide up to \$400 for alumni or middle/high school chapters to conduct a one-time service event. Mini-grant applications are always open and due on the first of each month. Complete the application here.

#### NATIONAL TEACHER AMBASSADORS FOR FFA

National Teacher Ambassadors for FFA are equipped to provide training and support related to the many educational resources and experiences offered through National FFA. State staff and agricultural teachers' association leaders are encouraged to view the <u>2023-24 ambassadors</u> to find teacher ambassadors in your state.

In serving teachers, National Teacher Ambassadors for FFA are expected to do the following:

- Present a minimum of one educational session about educational resources and opportunities on behalf of National FFA.
- Share or promote a resource or opportunity from National FFA every other month via state social media pages, state email lists, Ag Ed Discussion Lab on Facebook, Instagram or other relevant outlets.
- Be a positive, professional example to other teachers and stakeholders throughout the year of service and embody the FFA Value Statements in daily actions.

# **COMMUNICATION UPDATES**

#### STUDENT EMAIL ADDRESSES

Students are encouraged to use a personal email address rather than a school address for all FFA communication to ensure waivers and contest, program, and/or award information is delivered and accessible. Entering the advisor's address for all students as a short-cut will result in delivery issues later.

#### **CHAPTER AND TEACHER PROFILE**

Now is a great time to verify the information in your chapter and teacher profile. New features include allowing advisors to opt-in to email notifications for required actions that need to be completed in the roster or chapter profile, easy chapter-to-chapter transfer of members in the roster system, and the ability to view from 50 to 500 members per page in the roster system. ### **ShopFFA CONFIRMATIONS**

Watch for a confirmation email shortly after placing an order with ShopFFA if a valid email address has been provided. Advisors are asked to verify spelling, quantities and sizes to ensure correct personalization in the production process. ShopFFA staff is glad to make any needed changes if the error is caught quickly!



#### **AUTOMATED NOTIFICATIONS**

Double-check your personal profile in FFA.org to verify notification preferences for distribution of information as well as the method of notification (email, text or both). Agriculture teachers can also opt in to certain notifications via their personal profile in FFA.org. This ensures state staff and teachers are receiving the appropriate bulk communication from National FFA, such as The FFA Weekly, delivered most Fridays. \*Be sure to click all email lists you would like to subscribe to, even if you are already receiving emails.

Stakeholders who mention previously receiving this communication but who have not received it recently can be directed to sign up at <u>FFA.org/subscribe/</u>.

#### LICENSING GUIDELINES

Chapters, state associations and state foundations have permission to use the FFA Name and Marks (including the FFA Emblem) to publicize and promote FFA through public information, promotions and publicity events, educational programs, and motivational programs. However, chapters and associations seeking to create and order items bearing the FFA Name and Marks should <u>complete a Transfer License Request</u>. Not sure if the licensing transfer is needed?
